### 2. Frozen semen

The frozen semen collection fee is included in the breeding fee. The shipment includes 2 doses of frozen semen (16 straws). If more than 2 doses necessary, a fee of 100 € per 1 dose must be paid.

#### 3. Live cover

The stallion will do the natural cover in freedom or in hand unless otherwise specified by the owner of the stallion. The owner of the mare accepts this technique. Mare owner guarantees that the mare is free of contagious disease (metritis test less than a month old and viral arteritis) and up to date with deworming and vaccinations

The mare must be barefooted completely.

#### 4. Pension terms

The mare will be accommodated in agreement with its owner, in the meadow or in the box. The mare will benefit from all the necessary care. And if necessary, the owner of the broodmare in boarding mandates the seller to request on his behalf any veterinarian of his choice in order to treat, if necessary, the broodmare and/or her foal and agrees to pay the costs of the practitioner required in his name. As caretaker, the seller is insured for civil liability for the horses that are at his home. It is up to the owner to take out personal insurance to guarantee any event concerning his mare and foal. Any mare that is aggressive towards the stallion or represents a potential risk will be past aside. Its owner will be notified of the change in boarding or breeding condition. A hosting contract will be set up between the two parties.

## 6. Shipping

All shipping expenses and importation fees are the responsibility of the mare owner. Stallion owner declines all responsibility for any accident that could happen during the transportation of the semen.

- Stallion owner reserves the right to withhold issuance of a Breeders Certificate applicable to the breeding until mare owner is current on all payment obligations to stallion owner or/and veterinarian.
- This contract contains the "live foal guarantee" a live foal is described as a newborn in good condition after 24H of life.
  Rebreed privileges shall apply only to the next breeding season. If the mare miscarries, aborts her foal, or fails to produce a single foal that can stand up unassisted, stallion owner will allow mare owner re-breeding privilege of the mare to stallion (or a substitute mare is acceptable to the stallion owner). Provided that the mare owner furnishes a veterinarian's statement by a licensed veterinarian attesting to either occurrence within 30 days of the date of the occurrence.
- Pregnancy losses or confirmations should be reported to the stallion owner before the end of October in the year of breeding.
- Mare owner agrees to return shipping container to breeding station at mare owner expense within week from the date of receiving the container.
