



2025 BREEDING CONTRACT

This stallion frozen semen service contract, hereinafter designated contract, for the breeding season of 2025, is by and between Marie Haristoy , hereinafter designated « breeder » , and , hereinfater designated « mare owner » . Mare owner agrees to breed the mare to the stallion Nu Pops, hereinafter designated Stallion , subject to the following conditions.

1. 2025 stud fee is 1500 €.
2. NU POPS is HERDA N/N HYPP N/N MH N/N PSSM1 N/N GBED N/G
FRAME OVERO/OLWS N/N
3. In the 2025 breeding season the semen will be distributed by : Equitechnic chemin du Maris 14340 Notre Dame d'Estees / Corbon France
4. The stud fee of 1500 € has to be paid immediately .This contract becomes binding by both parties when the stud fee is paid and mare owner signs and returns one copy of the contract to the breeder.
5. This contract is meant to provide the mare owner a live foal. A live foal is defined as a newborn foal that stand and nurses without assistance for one week after the foaling . Should the foal die within the above-mentioned week, the breeder agrees on newly breeding the mare without asking the payment of the breeding fee and by observing the rules established by this contract.
6. This benefit will work even in case the mare is sold after the pregnancy check and before the foaling, on behalf of the buyer.
7. The breeder won't be liable for failure of the mare to get in foal or produce a live foal for any reason whatsoever. Should the mare fail to get in foal or produce a live foal, the stud fee will be kept by the breeder.
8. Mare owner specifically understans that the breeder and the stallion owner make no warranties or guarantees , expressed or implied, as to the fertilizing capacity of any semen provided or the stallion owner.
9. This contract is meant to provide the mare owner 2 doses (2x6) of frozen semen.
10. In the event that insemination using the standard two doses of the frozen semen for the breeding cycle do not result in a live foal as certified by a licensed veterinarian, breeder will provide additional two doses of frozen semen for each breeding cycle at an additional cost .

11. If the mare owner does not have his own dry shipper, the breeder will provide dry shippers for the transportation of the semen. The dry shipper has to be sent back to the breeder within 4 days after reception at his own expenses.
12. Mare owner is responsible for all costs related to the care of mare named above including all veterinary costs for whatever reason.
13. Pregnancy losses/confirmations must be immediately reported to the breeder via mail. All pregnant mare must be vaccinated for rhinopneumonitis at 5, 7 and 9 months of gestation or rebreed and live foal guarantees are not valid.
14. Once the foal is healthy on the ground (after one week from the birth), if some doses of semen are left, they return in the exclusive and sole property of the stallion's owner.
15. If ALL fees are not paid, the foal registration application will not be released.
16. This contract shall be governed with the laws of France. Any dispute will be resolved by the commercial court of Perpignan, France.
17. 2025 breeding fee season are so fixed
 . stud fee : 1500 €. EU shipment : 280 € . Domestic shipment : 180 €
