

BREEDING CONTRACT "Donated"

<u>BACKGROUND</u>: The owner or operator of the Mare, which subscribes to the following contract, undertakes to respect the conditions for payment and management below.

1) The undersignedagrees to fecundate the Mare described later, with the stallion - *CUSTOM BLACKBERRY* - AQHA Reg # 4405918 during the period of 2025 up to the following conditions:

2) One dose (2 paillette) of **FROZEN semen** was donated to **Equita Lyon "Stallion auction** 2024", to use in periods: from 01/02/2025 until 31/07/2025.

3) The cost of express courier are fully paid by the owner of the mare, before shipment.

4) This contract contains the "foal guarantee in life", a live foal is described as a newborn in good condition after the 3rd day of life.

The Mare, which were to have an interruption of pregnancy or birth a foal died, will be re fecundate but will not pay any rate mounts provided that such hardship is notified no later than the 7th day.

The owner of the Mare will strive to pay only the expenses for the collected semen and, of course, the cost of courier / carrier.

5) The "guarantee colt in life" will have value even in case of sale of the Mare, and this privilege is enshrined in the contract shot to the new owner.

The "<u>Registration Application</u>" for the foal conceived, will be issued only when all expenses have been paid.

6) The parties agree that if the Stallion dies or becomes sterile for some reason or if the mare dies or becomes unfit for conception, this Agreement is null and both parties will be relieved of any obligation contemplated here.

Similarly, any sum paid by the owner of the Mare on the rate of mounts, with the exception of the registration fee is not refundable, WILL 'BE RETURNED to the owner of the Mare. However, the mare owner will pay all other expenses incurred.

7) The parties agree that any discussions will be governed by the laws of the Italian State. Jurisdiction, Milan.

8) A photocopy of the Certificate of that Mare (both sides) must be attached to this contract. Note that the **"Stallion Breeding Report"** will be shown as owner of the Mare, the name written on the document (or the "Transfer Report"), even if different from signatory of the following contract.
