**Conditions**

1. Collection semen fee is € 100,00 VAT included;
2. **Seminal material is collected in the morning, three times a week, during the days of MONDAY, WEDNESDAY and FRIDAY. Semen collection must be ordered within 10.00 in the morning of the collection fee.**
3. Total amount must be paid entirely before the collection of the semen

4. In the case semen should be sent, shipment costs will be at mare's owner charge. Shipment of semen must be requested within 10.00 am of the collection day.
5. Quarter Dream SRL, as Stallion's Owner, will give the right to Re-breed:
  - in the case the mare reabsorbe, abort or die (with Vet Certificate)
  - in the case the foal die within 7 days from the date of birth (with Vet Certificate).
6. Re-breed cost will be 200,00 euro Vat included.
7. Special price and payment conditions will not be considered valid if the buyer does not respect the times and methods of payment and/or the agreed number of mares. This breeding is not transferable, except by prior agreement with the owner. The stud is considered lost only in the event that the stallion has died. This contract is valid for 3 years, starting from the 2024 Breeding Season. At the end of the three years, this contract is considered terminated by both parties, except for different agreements made with the property.
