The semen is collected in the morning three times a week only monday, wednesday and thursday.

YOU MUST REQUEST THE SEMEN BY 10.00 AM ON THE DAY OF THE SHIPPING

The Breeding Manager is not responsible for the untimely arrival or condition of the cooled transported semen as we have no control over the shipment after it leaves our custody.

If shipment is lost or delayed the mare owner assumes all risks of lost time and expenses associated with preparation of the mare for breeding.

The responsibility for conception is on mare owner. A qualified ,experienced licensed veterinarian competent in the use and handling of cooled semen should perform the insemination.

THE BREEDING FEE MUST BE PAID IN FULL BEFORE ANY SHIPMENTS ARE MADE ,UNLESS PRIOR ARRANGEMENTS ARE MADE WITH STALLION AGENT.

COLLECTION: The mare owner will be charged of € 100'00 for collection fee and container.

SHIPMENT COST to be payed before any shipment:

€ 100.00 delivery of the semen within the following day of dispatch.

€ 130.00 delivery of the semen within 12:00 AM of the following day (for the areas of destinations supplied by this service).

THE BREEDING SEASON BEGINS ON FEB.01 AND ENDS JULY 31

If the mare dies or became unfit for breeding the mare owner may substitute with another mare by notifying the breeding manager or stallion owner.

The mare owner is guaranteed one "live Foal.

owner of the stallion, will rebreed the mare only for the following year under these condition (Live Foal Guarantee):

-The mare reabsorbs;

-The mare aborts (medical certificate required and only up to 5 days after abort);

-The mare foals and the foal death no more than the 7th day foaling (medical certificate required). After the 7th day after foaling the owner of the stallion is free of any responsibility

FOR THE YEAR 2025 THERE WILL BE NO REBREED COST THEN IN THE FOLLOWING YEARS THERE WILL BE A COST OF € 150,00, PLUS SHIPPING AND COLLECTION COST, MUST BE PAID PRIOR TO ANY MARE BEING REBREED.

For the registration application, the confirmation of pregnancy and the fertilization date must be communicated to the breeding manager or stallion owner by 15 October.

If it is not communicated there will be a penalty of € 50.00

A breeding certificate will be issued to the mare owner by the stallion agent upon notification of the birth of the foal.
