Mare owner and stallion owner hereby agree as follows: Breeding Station: AMELIS EQUITECHNIC chemin du Marais 14340 CORBON (FRANCE) Tel: 0231322886 email : spalart@equitechnic.com

1. Stallion owner hereby sells, and mare purchases, a breeding during the 2022 breeding season to the following stallion :

ROOSTER NIC Reg. #<u>4832659</u> which entitles mare owner to breed following mare: Reg : **#** Breed :

Mare owner agrees to pay to stallion owner the fee of 1200 €

2. This fee is due and payable at the signature of this agreement and before semen will be shipped.

The shipment includes 2 doses of frozen semen -If more than 2 doses are necessary a fee of $90 \in$ per dose must be paid.

3. A fee of 180€ semen is due for each re-breed after the year of initial service (see point 5) for as far more doses frozen semen are necessary. Mare owner receives another 2 doses after payment.

4. There is a 100€ semen substitution fee for changing mares and a €100 substitution fee if the mare changes owner.

5. All charges in relation to the A.I. Centre/ veterinarian and in relation to the shipment (120€) of the semen are for the account of the mare owner. Stallion owner declines all responsibility for any accident that could happen during the transportation of the semen.

6. If the mare owner's mare is barren, aborts or fails to produce a single foal that can stand up unassisted and nurse, stallion owner will allow mare owner re-breeding privilege of the mare to stallion (or a substitute mare if acceptable to the stallion owner) in the next breeding season only. Provided that the mare owner furnishes a satisfactory certificate by a licensed veterinarian attesting to either occurrence within 30 (thirty) days of the date of the occurrence. See point 3.

7. Stallion owner reserves the right to withhold issuance of a Stallion Service or Breeders Certificate applicable to the breeding until mare owner is current on all payment obligations to stallion owner or/ and veterinarian.

The mare owner must report to the stallion owner all breeding dates before the end of October in the year of breeding (also report if mare is not in foal). If Mare Owner does not report, Jo CORBY will assume that the mare is not in foal and will *not include the Mare on the breeder's report and Mare Owner will incur a \$45 late charge to amend the breeders report if the mare is in foal.* Jo CORBY will issue a Breeder's Certificate upon the request of

the Mare Owner at any time after the mare has foaled and all charges have been paid in full. The Mare Owner may not assign, sell, or transfer this breeding contract to any other person or entity, nor may he/she substitute another mare for the Mare specified in this Stallion Service Contract unless in accordance with the provisions contained in this Contract. Any attempted assignment, sale, or transfer, or mare substitution without prior written consent of Jo CORBY will, at the sole option of Jo CORBY, terminate this Agreement and release Jo CORBY from all obligations hereunder. If the stallion dies, is sold, or, if in the opinion of Jo CORBY, the stallion becomes incapable of servicing mares for any reason, the mare owner has the right to breed to any other Horse at no additional charge.
