§1 Breeding Facts

The mare owner acquires for the _____ breeding season:

cooled semen o

frozen semen o

Fresh and frozen semen will be available in the time period of February 1st till 31st.
The stallion is available for American Quarter Horse and American Paint Horse mares. In case the stallion is not available due to illness or competition the stallion owner has the right to offer only frozen semen for this period of time. Competition dates will be published weeks up front. A pay back of the breeding fee is not possible in any of the above mentioned cases.

§2 Breeding Fee

The breeding fee is 1.200,- Euro.

Early booking is valid until January 31st of the breeding season with a reduced breeding fee of 950,- Euro. The registration of the mare comes along with a booking fee payment. The booking fee is 350,- Euro and is included in the breeding fee. The contract gets valid with the full payment of the booking fee. When making use of the early booking fee the full breeding fee has to be paid by January 31st of the breeding season. In general, the semen is only available after the breeding fee has been paid in full.

§3 Shipping

Fresh semen orders can be placed Mo.-Fr. until 09:00 p.m. for next day collection and shipment. The orders for fresh semen are limited to two orders within one cycle. The mare owner takes the expenses for collection, handling and shipping.

§4 Exclusion

excluded from breeding are

1. mares with infectious diseases and viruses,
2. mares that have failed to receive for several years,
3. mares that have not cycled correctly more than two times in a row.

The above mentioned mares will only be accepted for breeding in case a veterinarian certificate that proofs the proper status for breeding is provided.

§5 Life Foal Guarantee

The stallion owner gives a life foal guarantee for the following breeding season only. The above mentioned mare has rebreed privileges in case the foal is born dead or dies within 24 hours after birth (a veterinarian certificate is requested). Is the foal alive 24 hours after birth the life foal guarantee is no longer valid. In the rebreed year a fee of 350,- Euro for rebreed expenses has to be paid. A breeding fee will not be requested.

§6 Rebreed

The rebreed of a mare that failed to receive is possible in the following year only. The rebreed fee is 350,- Euro. Expenses for collection, handling and shipping are at the expense of the mare owner. A mare change is only possible after an agreement with the stallion owner. In case of an agreement a changing expense of 100,- Euro applies.

§7 Nomination

The stallion will be enrolled in the programs of NRHA Germany, Belgium and Italy for the above mentioned breeding season. An enrolment for following years is not guaranteed.

§8 Frozen Semen Breeding

1. the rebreed fee is valid for one frozen insemination per mare.
2. shipment expenses are to be paid by the mare owner.
3. the station can limit the number of frozen semen to two doses.
4. changing from fresh/cooled to frozen semen comes along with a frozen semen fee of 200,- Euro per dose.

§9 Final Clauses

Neither the stallion owner nor the breeding station take responsibility for the quality and the shipment of the semen.

§10 General

With the signature the mare owner declares that he or she accepts the breeding conditions. The contract will be valid through the signature of stallion and mare owner and is not transferable. Please send back the contract via mail or email to the agent Frozen Partners. A copy of the registration paper (front and backside) has to be included.
